1. Call to Order – Mrs. Hunt called the meeting to order at 10:00 a.m.

Mr. Richardson discussed replacing regular dinner menus at the Bistro with buffets on Friday and Saturday night beginning October 30 with some cooking or carving done at a buffet station. Mr. Richardson reported that the Sunday brunch hours and selections have been expanded.

The committee was asked to bring suggestions for menu selections, specials, etc. to the next meeting.

Mr. Richardson expressed the hope that patrons would come directly to the restaurant with comments, favorable and otherwise, so that issues could be addressed immediately.
